- 1. Statement of account to Current/Cash Credit/Overdraft account holders first copy to be provided free of cost and charges as above are to be levied for additional copies.
- 2. In case of lockers held by the Staff members the rent shall be charged at 50% of the charges prescribed for the applicable category of locker from time to time.
- 3. The term staff member shall include employees on permanent/Contract/ temporary basis.
- 4.No prepayment charges are to be recovered if the total repayments during a financial year do not exceeds the total amount of installments for the year plus 20% of the balance outstanding in a loan a/cs as at 31<sup>st</sup> March of the previous year.
